Mr. Hansen, Land Resources Subcommittee Chairperson, presented a report for the subcommittee meeting held on October 14, 2010.

Tree Program - 2010 Report – Mr. Hansen reviewed printed materials available in the Directors’ notebooks. Mr. Hansen reported that the information outlines the costs and income reported by the tree program in 2010, as well as previous years including a 10-year average. Mr. Hansen reported that the reduced demand for machine and hand planted trees and higher fuel prices have affected the net returns negatively.

Tree Program - 2011 Planning - Machine Planting Charges - Mr. Hansen reported that in the Directors’ Board meeting notebook were reports showing the TPNRD's tree program funds for 2010. Mr. Hansen reported that in 2007, the Board of Directors increased the tree planting charge from \$0.62 per tree for 2007 to \$0.74 per tree for 2008. Mr. Hansen reported that the tree planting charge in 2009 was \$0.75 per tree and in 2010 was \$0.77 per tree.

Mr. Hansen moved the Land Resources Subcommittee’s recommendation to the Board of Directors to approve that the TPNRD's tree stock charges be set by the General Manager based on the nursery charges to the TPNRD and that the TPNRD's machine planting charges be set at \$0.77 per tree for 2011. Ground Water Management – Variances – Rasby Land & Cattle – Mr. Meismer reported that the TPNRD received a request for a variance from Rasby Land & Cattle. Mr. Meismer asked Mrs. Dimmitt to report on the request.

Mrs. Dimmitt reported that the TPNRD received a request from Rasby Land & Cattle to de-certify and transfer 26.54 certified ground water irrigated acres from the NW ¼ Section 6, Township 13 North, Range 33 West, Lincoln County, Nebraska, within the same section but relocated under a pivot irrigating acres that used to be pasture. Mrs. Dimmitt reported that the 26.54 acres that were not certified are on the south side of the pivot. Mrs. Dimmitt reported that the same number of acres being transferred under the pivot will be removed from irrigation from the NW and NE corners of the pivot. Mrs. Dimmitt reported that there will be no new depletions to the river. Mrs. Dimmitt reported that in the Directors' Board meeting notebook was an aerial photo of the area.

Mrs. Dimmitt reported that the TPNRD received a request from Arden & Susan Krugerud (Rick Johnson) to de-certify and transfer 8.07 certified ground water irrigated acres from the SW ¼ NW ¼ Section 7, Township 13 North, Range 38 West, Keith County, Nebraska, within the same section but relocated under a pivot irrigating acres that were once building and not certified as irrigated. Mrs. Dimmitt reported that the 8.07 “new” acres that were not certified are along the west side of the pivot. Mrs. Dimmitt reported that the same number of acres being transferred to the “new” location or where a drain is now being irrigated by the pivot will be removed from irrigation from the northwest corner of the field. Mrs. Dimmitt reported that in the Directors’ Board meeting notebook was an aerial photo of the area.

Mrs. Dimmitt reported that the TPNRD received a request from Les Koehn and the Giesbret Living Trust to de-certify and transfer 2.5 certified ground water irrigated acres from the NW ¼ Section 26, Township 13 North, Range 34 West, Lincoln County, Nebraska, within the same section but relocated under a pivot irrigating acres that were once building and trees and not certified as irrigated. Mrs. Dimmitt reported that the 2.5 “new” acres that were not

Mrs. Dimmitt reported that prior to the purchase of this pivot by Les Koehn, the certified irrigated acres from the corners of the pivot in question were sold off and transferred to the pivot in the northwest. Mrs. Dimmitt reported that due to removing the buildings and trees so the pivot can go all the way around, the 2.5 acres were transferred back to the original pivot and placed under the pivot. Mrs. Dimmitt reported that there will be no new depletions to the river. Mrs. Dimmitt reported that in the Directors' Board meeting notebook was an aerial photo of the area.

Mrs. Dimmitt reported that the TPNRD received a request from Steve Scholz to de-certify and transfer 55.59 certified ground water irrigated acres from the N½ Section 11, Township 16 North, Range 29 West, Lincoln County, Nebraska, within the same section but relocated under the same pivot irrigating acres that were grass and/or CRP. Mrs. Dimmitt reported that the pivot was slid to the east to accommodate the expanding feed yard. Mrs. Dimmitt reported that the 55.59 acres that were not certified are on the east side of the existing pivot. Mrs. Dimmitt reported that the same number of acres being transferred under the pivot will be removed from irrigation from the east side of the pivot. Mrs. Dimmitt reported that a portion of the "new" shape on the east side of the pivot is currently CRP and will come out of CRP in October, so next year the entire area will be farmed as irrigated corn. Mrs. Dimmitt reported that there will be no new depletions to the river. Mrs. Dimmitt reported that in the Directors' Board meeting notebook was an aerial photo of the area.

Integrated Management Plan (IMP) - Rules and Regulations – Informal Public Hearing - Mr. Meismer reported that during the September 9, 2010 Board of Directors meeting, an informal public hearing was conducted by the Board for hearing testimony in regard to proposed amendments for the Districtwide Ground Water Management Area Rules and Regulations. Mr. Meismer reported that during the public hearing, Jeff Shafer, Nebraska Public Power District (NPPD), distributed and reviewed written testimony. Mr. Meismer reported that during the public hearing, Mrs. Dimmitt reported that she received an email just prior to the public hearing from Jennifer J. Schellpeper, Nebraska Department of Natural Resources (NE DNR), of which written testimony was attached to present during the public hearing and that since the Board meeting was not at the office, that she was unable to print the written testimony to present during the hearing. Mr. Meismer reported that following the public hearing, the Board of Directors agreed that they would like to see and consider the NE DNR written testimony and they would like to consider further the NPPD written testimony prior to taking action on amendments for the Districtwide Ground Water Area Rules and Regulations. Mr. Meismer reported that Mr. Rubenthaler asked the Water Resources Subcommittee to review and analyze the written testimony received from the NE DNR and NPPD and to prepare a recommendation for the Board of Directors. Mr. Meismer reported that on September 16, 2010, Mrs. Dimmitt, Harriet Hageman – Legal Counsel TPNRD, and Mr. Miller met with Brian Barels – NPPD and Jeff Shafer – NPPD to discuss the testimony presented by NPPD. Mr. Meismer reported that the meeting was brief, as Ms. Hageman recommended that the TPNRD should have detailed discussions with the other NRDs in the Upper Platte Basin and NE DNR as actions the TPNRD Board may decide to take could cause issues for the other NRDs. Mr. Meismer reported that on November 1, 2010, the NRDs in the Upper Platte Basin and NE DNR met with Brian Barels – NPPD and Jeff Shafer – NPPD to discuss the testimony presented by NPPD. Mr. Meismer reported that another
