Mr. Miller reported that Mr. Pieper resides in the North Platte Natural Resources District and is a current member of the North Platte Natural Resources District Board of Directors. Mr. Miller reported that candidates eligible are any resident in the North Platte Basin of majority age of 19. Mr. Miller asked if there were any other known candidates and there were none indicated.

Nebraska Natural Resources Commission - Middle Platte Basin - Caucus – January 11, 2001 – Grand Island, NE – Mr. Miller reported that the Nebraska Natural Resources Commission representative's term for the Middle Platte Basin expires in January 2001. Mr. Miller reported that Twin Platte Natural Resources District Directors, Mr. Rubenthaler and Mr. Wahlgren, reside in the Middle Platte River basin and are eligible to participate in the Middle Platte Basin Caucus, which will be held on January 11, 2001 in Grand Island, NE to select a representative for the Nebraska Natural Resources Commission for a 4 year term. Mr. Miller reported that the Central Platte Natural Resources District has 21 Directors that reside in the Middle Platte River basin and are eligible to participate in the Middle Platte Basin Caucus and the Tri-Basin Natural Resources District has 7 Directors that reside in the Middle Platte River basin and are eligible to participate in the Middle Platte Basin Caucus. Mr. Miller reported that the current representative for the Middle Platte Basin is Dick Mercer and that Mr. Mercer is not seeking re-election. Mr. Miller reported that candidates eligible are any resident in the Middle Platte Basin of majority age of 19. Mr. Miller asked if there were any other known candidates and there were none indicated.

<u>Nebraska Natural Resources Commission - South Platte Basin</u> - Mr. Miller reported that the representative's term for the South Platte basin expires in January 2003.

National Association of Conservation Districts – Dues Quota – 2001 – Mr. Miller reported that the Twin Platte Natural Resources District has not paid a District's dues quota since 1996 as directed by the Board of Directors in 1996. Mr. Miller reported that in the Directors' packet for information was a copy of a letter from Dayle Williamson to Tim Reich, National Association of Conservation Districts Secretary-Treasurer in which Mr. Williamson indicated that 22 of the 23 Natural Resources Districts in Nebraska have paid a quota for 2000 and that he was encouraging the Twin Platte Natural Resources District to contribute to bring Nebraska up to 100%. Mr. Miller reported that in the Directors' packet for information was an invoice from the National Association of Conservation Districts and the calculations for the minimum and maximum quota for the Twin Platte Natural Resources District and a letter dated March 6, 1996 from Jerry Vap, then the National Association of Conservation Districts President, in which Mr. Vap provided information requested by the Twin Platte Natural Resources District.
