Ground Water Management – Variances – Requests – Don Oppliger Ranch – Mr. Meismer reported that the TPNRD has received a request for two variances from the Don Oppliger Ranch. Mr. Meismer asked Mrs. Dimmitt to report on the request.

Mrs. Dimmitt reported that the TPNRD received a request from the Don Oppliger Ranch to drill a supplemental ground water well to irrigate his already certified ground water irrigated acres in the SE $\frac{1}{4}$ Section 2, Township 14 North, Range 35 West, Keith County, Nebraska.

Mrs. Dimmitt reported that the TPNRD received a request from the Don Oppliger Ranch to drill a supplemental ground water well to irrigate his already certified ground water irrigated acres in the NW $\frac{1}{4}$ Section 2, Township 14 North, Range 35 West, Keith County, Nebraska.

Mrs. Dimmitt reported that the Don Oppliger Ranch currently has a registered irrigation well irrigating a pivot of grass. Mrs. Dimmitt reported that this well pumps between 800 and 1,000 gpm. Mrs. Dimmitt reported that the supplemental well is being requested so that he may have access to an additional 300-500 gpm. Mrs. Dimmitt reported that if they were to replace the original well drilled in the 1970's, the formation would not allow for a 1,300-1,500 gpm well, therefore supplementing his existing well is determined to be the best option to allow an increase in pumping rate. Mrs. Dimmitt reported that in the Directors' Board meeting notebook was an aerial photo of the area.
